## EDITORIAL PREFACE

On 15-16 December 1994, a Conference on Philosophical Logic was organized at Ghent University on the occasion of the visit of an old friend, Graham Priest. The original plan concerned the Thursday afternoon workshop: Navigating around Inconsistent Structures —Graham Priest should be credited for the nice title. Later, others were invited to join the conference on Friday, with papers not restricted to the main theme. During the selection procedure (with the help of outside referees) and in view of the quality of the submitted abstracts, Thursday morning was included. It was a pleasure to see how, in a few weeks time, we were overwhelmed with excellent contributions from seven countries and three continents.

The conference received grants from the Belgian National Centre for Research in Logic (CNRL-NCNL) and from the Department of Philosophy of Ghent University. We are very grateful for their help. Support in kind has been obtained from the University and from its Faculty of Philosophy and Letters. We want to express our warmest gratitude to each of them.

Two contributors dropped out at the last moment, which gave us the opportunity to have a discussion (prepared by Priest, Read, Van Bendegem and Batens) on some points of deep disagreement, such as the existence of a true logic, the meaning of negation, and mathematical finitism. During the colloquium, the decision was taken to organize the *First World Congress on Paraconsistency* in Ghent from 30 July to 2 August 1997 (WCP97@rug.ac.be).

The acta of the colloquium are published in the present (143-144) and the next (145) volume of *Logique et Analyse*, the house journal of the Belgian National Centre for Research in Logic. Some authors dropped out and some preferred to replace their contribution. The distribution of the papers over both volumes was influenced by the format of the journal, but as both appear at the same time, this will not spoil the reader's fun.
