In the present volume we have ordered the papers in three groups. The papers by Lucas and Lavendhomme, Vandamme, Van Bendegem and Batens contain an exposition or discussion of formal systems. The second group of papers, viz. those by Havas, Phalet and Vergauwen, concern the philosophy of logic, all relying on recent developments in logic. Finally, the papers by Leman, Lowenthal, Kuipers and Hilpinen discuss the rele-

vance of formal logic to specific other domains. The materials presented at the conference by Paul Weingartner will be published in a joint paper with G. Schurz, to appear in *Poznan Studies in the Philosophy of the Sciences and the Humanities*, vol. 10 edited by Theo A. F. Kuipers.
